## **SPECIFIC OBJECTIVE**

The specific objective of this project is WOMEN EMPOWERMENT. It will work towards the health and hygiene of girl children in government high and higher secondary schools. Its main objective is to construct special rooms for the girl children to rest during menstrual periods. These rooms will be called PINK ROOMS.

The construction of “Pink Rooms” in schools to provide a comfortable and hygienic space for girls to rest during menstrual periods is a valuable initiative.

### **1. Menstrual Hygiene Management (MHM):**

- Provide a Safe and Hygienic Space: To create a clean and private environment where girls can manage their menstrual hygiene effectively.
- Access to Sanitary Facilities: To ensure that girls have access to clean and well-maintained toilets and handwashing facilities within the Pink Rooms.

### **2. Promoting School Attendance and Retention:**

- Reduce Absenteeism: To minimize the number of school days missed by girls due to menstrual discomfort and related challenges.
- Improve Concentration: To enable girls to stay in school throughout the day, promoting better concentration and learning.

### **3. Empowerment and Education:**

- Educational Workshops: To conduct workshops on menstrual hygiene, reproductive health, and self-care within the Pink Rooms.
- Promote Self-confidence: To help girls build self-confidence by addressing the stigma associated with menstruation.

- Provide Comfort: To ensure that the Pink Rooms are equipped with comfortable seating and resting areas to alleviate physical discomfort.


